Public Participation:

It is the policy of the Approval Authority to encourage and permit public participation and comment on matters within the Approval Authority's jurisdiction, as follows.

- Public Comment on Agenda Items. The Approval Authority will take public comment on each item on the agenda. The Approval Authority will take public comment on an action item before the Approval Authority takes any action on that item. Persons addressing the Approval Authority on an agenda item shall confine their remarks to that particular agenda item. For each agenda item, each member of the public may address the Approval Authority once, for up to three minutes. The Chair may limit the public comment on an agenda item to less than three minutes per speaker, based on the nature of the agenda item, the number of anticipated speakers for that item, and the number and anticipated duration of other agenda items.
- General Public Comment. The Approval Authority shall include general public comment as an agenda item at each meeting of the Approval Authority. During general public comment, each member of the public may address the Approval Authority on matters within the Approval Authority's jurisdiction. Issues discussed during general public comment must not appear elsewhere on the agenda for that meeting. Each member of the public may address the Approval Authority once during general public comment, for up to three minutes. The Chair may limit the total general public comment to 30 minutes and may limit the time allocated to each speaker depending on the number of speakers during general public comment and the number and anticipated duration of agenda items.
- *Speaker Identification*. Individuals making public comment may be requested, but not required, to identify themselves and whom they represent.
- *Designated Public Comment Area*. Members of the public wishing to address the Approval Authority must speak from the public comment area.

- Comment, Not Debate. During public comment, speakers shall address their remarks to the Approval Authority as a whole and not to individual Approval Authority representatives, the General Manager or Management Team members, or the audience. Approval Authority Representatives and other persons are not required to respond to questions from a speaker. Approval Authority Representatives shall not enter into debate or discussion with speakers during public comment, although Approval Authority Representatives may question speakers to obtain clarification. Approval Authority Representatives may ask the General Manager to investigate an issue raised during public comment and later report to the Approval Authority. The lack of a response by the Approval Authority to public comment does not necessarily constitute agreement with or support of comments made during public comment.
- Speaker Conduct. The Approval Authority will not tolerate disruptive conduct by
 individuals making public comment. Speakers who use profanity or engage in yelling,
 screaming, or other disruptive behavior will be directed to cease that conduct and may be
 asked to leave the meeting room.

REGULAR MEETING MINUTES DRAFT

1. Roll Call

UASI Chair Mary Ellen Carroll called the meeting to order at 10:02 AM and General Manager Craig Dziedzic subsequently took the roll. Vice-Chair Lucia was present. Members Michael Cochrane, Toshia Shavies Marshall, Raymond Riordan, Dana Reed, and Gerry Malais were present. Members Mike Casten, Bob Doyle, Mark Robbins, and Christopher Godley were absent, but their alternates, Chris Simmons, Rick Navarro, and Scott Kirkpatrick were present. There was no alternate for Christopher Godley.

2. Approval of the Minutes

Motion: Approve the minutes from the November 14, 2019 Approval Authority meeting.

Moved: Member Malais Seconded: Member Riordan

Vote: The motion was passed unanimously.

Chair Carroll asked for any comments or questions concerning the minutes from the November 14, 2019 meeting.

Member Malais requested more details be placed within the minutes to reflect the discussion between the members and the public.

General Manager Dziedzic said he would check with legal counsel to see if our minutes as written are considered appropriate.

Chair Carroll asked the General Manager to make an inquiry and provide an update at the next meeting.

Two members of the public also requested more detailed minutes.

3. General Manager's Report

(a) FY20 UASI Grant Update

General Manager Craig Dziedzic notified the Approval Authority that the FY 2020 Consolidated Appropriations bill was signed into law on December 20, 2019. This bill provides discretionary funding for all federal agencies including the Departments of Justice and Homeland Security. Funds from this bill will support these departments through the end of the fiscal year, September 30, 2020. Funding for grant programs will increase slightly by providing \$665 million for the Urban Areas Security Initiative.

(b) RCPGP and STC Grants Updates

General Manager Dziedzic provided updates on the Regional Catastrophic Preparedness Grant Program (RCPGP). On December 17, 2019 the Management Team was awarded \$1.4 million by FEMA for the RCPGP Grant. The Management Team is preparing the Accept and Expend legislation for approval by the San Francisco Board of Supervisors.

On December 4, 2019, the Management Team discussed the Securing the Cities grant application with representatives from the Countering Weapons of Mass Destruction (CWMD) Office. The UASI Management Team initially requested approximately \$7.3 million, but were informed that the award would not exceed \$2 million. A revision of the budget and budget narrative reflecting this change was required. The Management Team submitted the revised documents and are currently waiting for the official award letter.

(c) 2020 National Homeland Security Conference

General Manager Craig Dziedzic provided Approval Authority members with information on the upcoming National Homeland Security Conference.

The 2020 National Homeland Security Conference will be held in Chicago, IL (June 29 – July 2). The Management Team submitted three panel presentations highlighting regional, collaborative, and whole community preparedness initiatives of the Bay Area UASI.

These presentations include the following:

- 1. Bridging the Gap Between Cybersecurity and Emergency Response
- 2. How to Effectively Sustain Grant Funded Programs
- 3. Leveraging Federal Partnerships in Building and Sustaining a Regional Preventive Radiological/Nuclear Detection (PRND) Program

(d) Management Team Tracking Tool and Future Agenda Items

There were no additions to the tracking tool.

A member of the public made a comment with multiple areas of concern.

Member Marshall asked General Manager Dziedzic for clarification on the allotments in the FY 20 Consolidated Appropriations bill.

General Manager Dziedzic clarified that the allocations will cover all UASIs.

4. Election of UASI Officers

Chair Carroll and Vice Chair Lucia conducted a vote on the positions of UASI Chair and Vice Chair for the 2020 term.

Motion: Elect Member Carroll to remain Chair of the UASI for the 2020 term.

Moved: Vice Chair Lucia Seconded: Member Riordan

Vote: The motion was passed unanimously.

Motion: Elect Vice Chair Lucia to remain Vice Chair of the UASI for the 2020 term.

Moved: Member Cochrane **Seconded:** Member Malais

Vote: The motion was passed unanimously.

Chair Carroll thanked the board for electing her as Chair.

Vice Chair Lucia thanked the board for electing him as Vice Chair.

5. <u>UASI FY20 Sustainment and Proposed Regional Projects</u>

Regional Grants Manager Mary Landers presented the FY20 UASI Sustainment and Regional Projects. She advised that the Proposal Guidance required the Bay Area UASI Management Team to report all regional proposal submissions to the Approval Authority. Additionally, the funding recommendations are based on the region's risk and gaps as well as funding availability.

Three (3) sustainment projects were presented directly to the Approval Authority. The projects were: Training and Exercise, Fusion Center, and Public Safety Information Sharing.

(a) Training & Exercise Annual Report

Regional Program Manager Janell Myhre and SenseMakers, LLC President Jim Bailey requested funding for the Regional Training and Exercise Program in the amount of \$4,151,339.

Both Janell Myhre and Jim Bailey explained the shared duties approach that will be taken to ensure the success of the Training and Exercise program. They also will provide status reports on the Regional Training and Exercise program at each Approval Authority meeting in 2020.

(b) Northern California Regional Intelligence Center Annual Report

NCRIC Director Mike Sena requested funding the NCRIC in the amount of \$5,211,473. He expressed that the amount requested would be used in the Terrorism Liaison Officer Outreach

Program (TLOOP). This would provide outreach and training to regional partners and enable the NCRIC to fulfill its responsibilities with other partnering agencies and stakeholders.

Director Sena also gave an overview on the NCRIC's training and pilot projects of 2019.

(c) Regional Information Sharing System Annual Report

NCRIC Assistant Deputy Director Brian Rodrigues briefed the Approval Authority on the Regional Information Sharing System and the Proposed FY20 Allocation.

He informed the board that there are over 1000 active users of the Regional Information Sharing System and the NCRIC receives over 50,000 queries a month. To share information they have modernized their technology and deployed new platforms.

(d) All other regional projects

Regional Grants Manager Mary Landers provided information on all FY20 Project Submissions.

She informed the Board that this is an action item and requested approval as presented.

Motion: Approve the funding amounts as recommended by the Management Team.

Member Reed asked if the funding allocated to the NCRIC was sustainable.

General Manager Dziedzic and Director Sena both explained that other funding options were being explored.

Member Navarro inquired about the suggested funding for the SF Bay Area Mass Notification System Users Conference. He wanted to know why the Management Team recommended \$100,000 when the original request was for \$60,000.

General Manager Dziedzic explained that there will be fewer sponsors supporting the conference so the Management Team is recommending additional funding.

Member Reed inquired about the \$750,000 savings from the Training and Exercise Program.

General Manager Dziedzic indicated that the savings will be split equally between the 4 hubs.

Chair Carroll suggested that there should be more closed session presentations by the NCRIC.

General Manager Dziedzic indicated that the Management Team would work with the NCRIC to add these sessions.

A member of the public made a comment about the original and current budget. He stated that the amount of money allocated to community preparedness was insufficient.

A member of the public made an inquiry about the T&E program and asked if the closed sessions could be made public.

6. Risk Management Kick-Off 2020

Project Manager Amy Ramirez presented the 2020 Risk Management kick-off.

She informed the board that the Management Team completed the planning for the 2020 risk management cycle. The Management Team worked with their partners, NCRIC and Haystax, to make this kick-off possible. The Management Team and their partners were focused on FEMA's requirements for the Stakeholder Preparedness Review (SPR). Some of the scheduled will be webinars, asset reviews, making new templates and updating ongoing programs.

No comments were made.

7. FY17 UASI Spending Report

Chief Financial Officer Tristan Levardo provided an update on FY 2017 grant expenditures.

Member Malais asked about the left over funds.

Chief Financial Officer Tristan Levardo explained that the money from the "left over funds" were added to the FY19 funds.

8. Announcements - Good of The Order

A member of the public made a comment with multiple areas of concern.

Project Manager Phil White requested that the Approval Authority meeting be adjourned in honor of Alameda County Sheriff's Commander Tom Wright who recently passed away.

Vice Chair Lucia provided some remarks about the Commander and adjourned the meeting in Tom Wright's memory.

Discussion/Description:

(a) UASI FY 2020 NOFO (Discussion)

On February 14, 2020, the Department of Homeland Security released the NOFO for the 2020 Homeland Security Grant Program (HSGP). Unlike previous NOFOs, instead of a fixed amount, the allocations under the UASI program were presented in range format. The lower amount is guaranteed, and the higher end amount is subject to the jurisdiction addressing the following four national priorities:

- 1. Enhancing cybersecurity (including election security) 5% of allocation
- 2. Protection of soft targets/crowded places (including election security) 5% of allocation
- 3. Enhancing info/intel sharing and cooperation (fusion center) 5% of allocation
- 4. Emergent threats (unmanned aerial systems. CBNRE) 5 % of allocation.

The Bay Area UASI received an allocation range of \$30,000,000 - \$37,500,000 which is a significant increase from last year's award (\$27.5 million). Failure to address the national priorities would result in receiving a reduced award. Submitted proposed projects addressing the national priorities will be competitively evaluated based upon DHS/FEMA's criteria of effectiveness.

The NOFO strongly encourages applicants to apply for funding at least 15% over the high end of the target allocation range as ineffective applications will not be funded. Pursuant to the direction of the NOFO, the Bay Area UASI intends to submit an application amounting to 20% over \$37.5 million (i.e., \$45 million).

(b) Securing the Cites (STC) Grant Program (Discussion)

The Countering Weapons of Mass Destruction (CWMD) office, the agency overseeing the STC grant program notified the Bay Area UASI of its selection for the program, which is prescriptive grant with a 10 year performance period. The goals of the grant are to reduce the risk of a successful deployment of a radiological nuclear weapon in a large geographical area, and to achieve a unified approach that leverages federal, state, and local assets. A \$2 million dollar award will be offered the first year to build out an organizational structure that covers the Northern California 48 counties, including Washoe County, Nevada. Each year grant recipients must submit an application for further funding,

On March 4th, the Bay Area UASI will be meeting with CWMD officials to discuss strategy, best practices, and to receive the official award letter.

(c) Management Team Update (Discussion)

Contracts Specialist Position

Scott Kaplan is our new Contracts Specialist who will be providing contracts administrative support for the grants management team. His duties will involve managing/developing contracts, MOUs/LOAs, monitoring, and performing desk audits.

Scott has more than four years of experience working as an administrative analyst with the San Francisco Public Utilities Commission performing comparative analysis of Federal, State, and local laws, regulations, and policies.

He holds a Bachelor of Arts degree in political science from the California Polytechnic University, Pomona, CA, and he is working on his master's degree in public administration from the University of San Francisco.

Scott has always been active in the community through volunteer opportunities and sports. He was a member of the City of Burlingame Youth Advisory Committee during high school. He also co-founded and was the first president of the Eire Og Gaelic Football Club. He also enjoys the outdoors, staying active through sports, and baking.

(d) The UASI Meeting Minutes (Discussion/Possible Action)

During the January 9, 2020 Approval Authority meeting, the General Manager was requested to have legal counsel review the currant format of the Approval Authority minutes. This format was previously approved by the Approval Authority at the April 12, 2012 meeting. Based on the review of both the legal counsel for the Bay Area UASI and the San Francisco City Attorney's Office, the opinion rendered was that the format, described as "action minutes" complies with the Brown Act.

Staff Recommendation:

Approval of \$11.7 million for regional projects supporting the four National Priorities pursuant to the UASI FY 2020 Notice of Opportunity Funding (NOFO).

Action or Discussion Item:

Action.

Discussion

In order to apply for the upper range of the grant award, the UASI FY 2020 NOFO requires funding four national priority initiatives – each one to be funded at 5% for a total of 20%.

Failure to fund the four national priorities will result in a recipient receiving a reduced grant award. DHS/FEMA will not award funding in excess of a recipient's minimum allocation threshold to the extent that investments and projects do not align with these four priority areas.

Listed in Table One below are the four national priories and the proposed associated projects for a total of \$11.7 million – 20% of the grant award. The projects were selected after discussions with our regional subject matter experts on which projects closely satisfy the requirements of the NOFO, including alignment to the region's THIRA/SPR and meeting the criteria for effectiveness, which will be competitively reviewed by DHS/FEMA. All projects are scalable and funding for each National Priority is targeted at \$2,939,726.

Table 1: FY20 UASI National Priority Projects

Enhancing Cybersecurity	Project Description
Cyber-Intelligence & Security Project	Funding for Fusion Center cyber analysts; cyber vulnerability assessment hard and software; development of regional cyber resilience and response plans. This project would increase the number of cyber threat intelligence reports developed in coordination with DHS.
Cyber Navigator Program	Develop a Cyber Navigator program that would help election authorities defend against cyber breaches and detect and recover from cyberattacks. The navigators would provide assessments, training, support and election cyber resilience services to local election officials.

Virtual Security Operations Center	Establish a Virtual Security Operations Center (V-SOC) to protect the region's cybersecurity posture, which includes elections security.





This memo presents total local funding available and then presents detail on proposed allocations, including regional projects and hub funding amounts.

1. <u>Total Local Funding Available</u>

On February 14, 2020, the Department of Homeland Security released its FY20 Homeland Security Grant Program Notice of Funding Opportunity, which includes the FY20 UASI grant award for the Bay Area. The Bay Area UASI federal grant allocation for FY20 is \$30,000,000 up to \$37,500,000, with an option to submit an application amounting to \$45M subject to the National Priorities requirement. The projects geared towards those National Priorities will have to go through an evaluation process. The State of California has not informed us on the amount of funding they will retain. For illustration purposes, the retention is set at 17.3% of the grant award as previously used in FY19.

Table 1 below shows total local funds available for allocation and provides FY19 information as reference.

3. **Hub Allocations**

There is a proposed amount of \$6,393,481 for the FY20 allocation to hubs. The total amount is comprised of the baseline allocation of \$5,643,481, and \$750,000 derived from the blended Training and Exercise program, which is divided equally among the hubs. This baseline amount is distributed to the four hubs based on the risk allocation percentage approved by the Approval Authority in the November 2019 meeting:

- East = 23% (23.60)
- North = 7% (6.60)
- South = 25% (25.10)
- West = 45% (44.70)




2020 Timeline

Community Preparedness Training & Exercises

The Bay Area UASI is pleased to announce the start of the new Bay Area Training & Exercise Program (TEP) which includes traditional first responders and Whole Community partners. We have teamed with San Francisco Community Agencies Responding to Disaster (SFCARD) to help ensure all community preparedness partners voices are heard as we identify the regions training and exercise needs. The administration of the Bay Area TEP will be a joint public/private approach led by the UASI Management Team, supported by SFCARD and SenseMakers LLC.

Community Preparedness Highlights

Community Engagement.

There will be reoccurring monthly meetings facilitated by SFCARD with regional community partners including Collaborating Agencies' Disaster Relief Effort (CADRE), Alameda Volunteer Agencies Active in Disaster (VOAD), Center for Volunteer Nonprofit Leadership (CVNL) and others to discuss training and exercise needs, share information about the Bay Area TEP activities, and provide a platform for ongoing stakeholder feedback.

Integration with the Training & **Exercise Workgroup.** The information gathered from the ongoing community preparedness meetings will be presented by SFCARD at the monthly Training & Exercise Workgroup (TEWG) Meetings. The TEWG is representative of the larger Bay Area region and includes all disciplines- and now it will include representation from community preparedness!

Community Preparedness

Liaison. The role of SFCARD, and its coordination with both regional and local community organizations, is a highlight of the new Bay Area TEP. A Community Preparedness Liaison will be the point person for all community preparedness organizations, to ensure a seamless, consistent and supportive framework for the various community preparedness agencies within the region.

Training & Exercise Planning Workshop (TEPW). The

purpose of the TEPW is to gather the information needed to create the Multi-Year Training and Exercise Plan (MYTEP) which will serve as the roadmap for the Bay Area TEP. Starting this year, the identified community preparedness training and exercise needs, as a result of the information gleaned in the Community Survey taken in October 2019, will be included in the MYTEP.

Community Preparedness Training and Exercises.

Following approval of the Multi-Year Training and Exercise Plan, training course deliveries are expected to begin in July 2020. Community preparedness partners will have an opportunity to participate in a wide range of training and exercise events, many of which were identified in Fall 2019 assessments, and others that will be new and exciting for all! Our vision is to provide frequent opportunities for community partners and first responders to train *together* – allowing for training that will more closely mirror a real-world response.

Community Preparedness

Annual Report. At the conclusion of each calendar year SFCARD will document activities completed and distribute a stakeholder survey. The Annual Report will highlight the training courses completed, organizations trained, program next steps, survey results and process improvements to continually enhance community preparedness within the region.

EXECUTIVE SUMMARY

The 2019 Critical Transportation Tabletop Exercise Series was designed to engage the stakeholders that play a role in critical transportation operations and promote collaboration between jurisdictions and agencies as will be necessary following a catastrophic earthquake. Participating agencies included representation from FEMA Region IX, U.S. Department of Transportation, National Weather Service, U.S. Coast Guard, California Governor's Office of Emergency Services, California Department of Transportation, California Highway Patrol, the 12 Bay Area counties, Metropolitan Transportation Commission, and Bay Area Transportation Agencies.

The exercise tested five core capabilities and evaluated four objectives as summarized in Table ES-1.

Table ES-1: Core Capabilities and Exercise Objectives

Core Capabilities:

- Critical Transportation
- Operational Coordination
- Logistics and Supply Chain Management
- Public Information and Warning
- Situational Assessment

Objectives:

- 1. Exercise and evaluate local Mass Transportation/Evacuation Plans, MTC's Regional Transportation Emergency Management Plan, and the critical transportation portions of the Bay Area Earthquake Plan.
- 2. Evaluate response and resource coordination requirements between local, state, and Federal agencies and transportation partners following a catastrophic incident.
- 3. Discuss regional processes of gaining and maintaining situational awareness and establishment of a common operating picture including the use of WebEOC and Cal COP.
- 4. Discuss integration of public information functions with response efforts.

Through observations gathered during the regional and four Hub tabletop exercises, post-exercise debrief conversations, and review of participant feedback forms, evaluators identified several strengths and areas for improvement. A summary of the notable strengths and improvement recommendations common to all participants are included in this executive summary.

The comprehensive analysis and Regional Improvement Plan is presented in the full After-Action Report which is designated "for official use only" and available to participating Bay Area UASI jurisdictions.

Executive Summary 1 BAUASI





Strengths

- Exercise participants found the Cal OES, MTC, PIO, Med/Health, and National Business Emergency Operations Center mock coordination calls useful and added context to how information would be shared followed a catastrophic event.
- The fuel distribution plan is well developed in the Bay Area Earthquake Plan.
- Bay Area transportation agencies indicated they would have a general assessment of internal capabilities/limitations within 4-12 hours (depending on the size of the agency and infrastructure).
- Most emergency management agencies provide route status information through both their JIC and their transportation agencies to ensure that the information is in both places.
- The Bay Area Joint Information System has good strategies and techniques to address public-information sharing.

Improvement Recommendations


- Bay Area Operational Areas should continue efforts to:
 - O Develop or update transportation annexes/plans to ensure that information about Access and Functional Needs (AFN) populations, commodity distribution (last mile), mutual aid, and reimbursement requirements are included or referenced in subsequent plans.
 - o Refine plan elements to logically address potential routes, potential sites, and the incident-specific selection process for both.
 - o Develop protocols and appropriate communication channels to share time-sensitive information with AFN populations and other groups in an effective manner.
- The Bay Area region should explore strategies or methods that could allow for the transportation community, and other agencies not on WebEOC/Cal EOC, to utilize a single platform for sharing information/developing a common operating picture.
- Collectively, Bay Area and state agencies should provide additional information and training on the Critical Transportation Task Force to include:
 - o Differences between the task force and an EOC transportation branch (planning vs. operations).
 - o Roles/responsibilities of the task force.
 - O Understanding of the terminology used within this task force and the differences when compared to a task force that is frequently used in transit.



EXECUTIVE SUMMARY

This tabletop exercise was conducted from 9:00 AM-12:30 PM Pacific Time (PT) at the Bay Area Metro Center Building at 101 8th Street, Oakland, CA, 94607.

At the beginning of each of three modules, participants received a scenario briefing that summarized key events. Following each of these updates, facilitators led a plenary group discussion that was driven by questions about critical transportation related to heat, wildfires, and air quality concerns affecting the San Francisco Bay Area.

The exercise tested four core capabilities and evaluated three objectives as summarized in Table 1.

Executive Summary 3 BAUASI



	Strengths
1	Most paratransit agencies have a variety of communications systems in place, including Nixle, Everbridge, Nextdoor, Facebook, and Twitter. These means of communication are used to notify internal and external stakeholders of an emergency event.
2	Many agencies have multiple methods to communicate with workers and drivers, such as cell phones, radios, Mobile Data Terminals (MDT), and satellite phones.
3	Paratransit staff are very willing to work during an emergency event, although they may not live near their respective workplaces. Additionally, contracted personnel are not mandated Disaster Service Workers (DSW) under California state law, which would otherwise <i>require</i> them to work.
4	Some paratransit agencies coordinate with private-sector companies such as Uber, Lyft, school bus companies, and ambulance services, and look to them for assistance during an emergency event.

	Improvement Recommendations
1	All agencies need ongoing emergency preparedness education. Additional drills and exercises that include a paratransit component are essential.
2	Not all paratransit agencies have an Emergency Operations Plan and/or a Continuity of Operations Plan. Currently, these plans are not consistent from one jurisdiction to another, and some have not been updated for some time. Updated plans that incorporate lessons learned and best practices will enhance interagency coordination and preparedness across the Bay Area.
3	As contracted employees do not fall under the California Disaster Service Worker designation, paratransit agencies should incorporate emergency roles and responsibilities into service contracts.





Findings – Principle Sources

Confirmed Five Principal Sources of Grocery for the Bay Area:

- Albertsons (Safeway): 24 to 26 percent
- Super Store Industries: 21 to 23 percent
- C&S Wholesale: 11 to 13 percent
- UNFI (Supervalu): 11 to 13 percent
- Walmart: 10 to 12 percent

















Findings – Private Sector Priorities

All five of the principal sources of grocery in the Bay Areas articulated the same priorities:

- Access to information, especially on the status of retail locations.
- Access to roadways, especially into their Distribution
 Centers and between DC's and retail locations.
- Access to fuel for their trucking fleets and back-up generators.



Recommendations

To facilitate the development of effective policies and procedures to advance resilience of the grocery supply chain, the UASI should:

- Establish a permanent task force on Supply Chain Resilience.
- Undertake a collaborative relationship with the California Resiliency Alliance to engage grocery and other key supply chain owners and operators.
- Engage with local, state, federal efforts related to coordination of cross-sector operations, including stabilization of key supply chains and community lifelines..." (ESF-14).




Bay Area Regional Events and their contribution to our regions Relative Risk Score


