Public Participation:

It is the policy of the Approval Authority to encourage and permit public participation and comment on matters within the Approval Authority's jurisdiction, as follows.

- Public Comment on Agenda Items. The Approval Authority will take public comment on each item on the agenda. The Approval Authority will take public comment on an action item before the Approval Authority takes action on that item. Persons addressing the Approval Authority on an agenda item shall confine their remarks to the particular agenda item. For each agenda item, each member of the public may address the Approval Authority once, for up to three minutes. The Chair may limit the public comment on an agenda item to less than three minutes per speaker, based on the nature of the agenda item, the number of anticipated speakers for that item, and the number and anticipated duration of other agenda items.
- *General Public Comment*. The Approval Authority shall include general public *comment* as an agenda item at each meeting of the Approval Authority. During general public comment, each member of the public may address the Approval Authority on matters within the Approval Authority's jurisdiction. Issues discussed during general public comment must not appear elsewhere on the agenda for that meeting. Each member of the public may address the Approval Authority once during general public comment, for up to three minutes. The Chair may limit the total general public comment to 30 minutes and may limit the time allocated to each speaker depending on the number of speakers during general public comment and the number and anticipated duration of agenda items.
- *Speaker Identification*. Individuals making public comment may be requested, but not required, to identify themselves and whom they represent.

- *Designated Public Comment Area*. Members of the public wishing to address the Approval Authority must speak from the public comment area.
- *Comment, Not Debate.* During public comment, speakers shall address their remarks to the Approval Authority as a whole and not to individual Approval Authority representatives, the General Manager or Management Team members, or the audience. Approval Authority Representatives and other persons are not required to respond to questions from a speaker. Approval Authority Representatives shall not enter into debate or discussion with speakers during public comment, although Approval Authority Representatives may question speakers to obtain clarification. Approval Authority Representatives may ask the General Manager to investigate an issue raised during public comment and later report to the Approval Authority. The lack of a response by the Approval Authority to public comment does not necessarily constitute agreement with or support of comments made during public comment.
- *Speaker Conduct.* The Approval Authority will not tolerate disruptive conduct by individuals making public comment. Speakers who use profanity or engage in yelling, screaming, or other disruptive behavior will be directed to cease that conduct and may be asked to leave the meeting room.

1. <u>Roll Call</u>

UASI Chair Anne Kronenberg called the meeting to order at 10:00 AM and subsequently took the roll. Chair Anne Kronenberg and Vice Chair Rich Lucia were present. Members Raemona Williams, Cathey Eide, Ryan Broughton, Kevin Oakley and Al Terrell were present. Members Ken Kehmna, Mike Casten, Bob Doyle and Trisha Sanchez were absent, but their alternates, respectively Dana Reed, Mark Williams, Dave Augustus and Mark Robbins, were present.

2. <u>Closed Session: National Counterterrorism Threat Center Briefing</u>

An NCTC Liaison provided a threat briefing to Approval Authority Members.

4. General Manager's Report

(a) UASI FY17 Project Proposal Process

General Manager Craig Dziedzic updated the Board on the status of the Bay Area UASI FY17 project proposal process. The Management Team received 158 applications which are currently in the review process. Approval Authority Members will have the opportunity to review their jurisdiction's proposals from November 14 to December 2, 2016 to ensure consistency with their own operational area and/or core city priorities.

(b) The National Fusion Center Association (NFCA) Annual Training Event

Mr. Dziedzic reported on the recent NFCA Conference hosted in Alexandria, Virginia. The General Manager and NCRIC Staff participated in panels on Cyber Security for Critical Infrastructure and Special Event Support/ Real Time Open Source Analysis. Keynote speakers at the event included Director of National Intelligence James Clapper, and FBI Director James Comey.

(c) 2017 National Homeland Security Conference

Mr. Dziedzic reported that the 2017 National Homeland Security Conference is scheduled to take place in Buffalo, NY from June 6 - 8, 2017. The National Homeland Security Association (NHSA) is currently accepting presentation proposals through December 15, 2016. He stated that the Management Team will be submitting proposals for the upcoming conference.

5. <u>FirstNet Briefing</u>

BayRICS General Manager Barry Fraser introduced FirstNet CEO Mike Poth and FirstNet Region IX Continental U.S. Lead Lesia Dickson, who provided an update on FirstNet's progress and considerations for the Bay Area region. Chair Kronenberg thanked them for their efforts to enhance first responder safety and abilities throughout the region.

6. <u>2016 Threat and Hazard Identification and Risk Assessment (THIRA)</u>

Assistant General Manager Catherine Spaulding provided an update regarding the 2016 THIRA. The THIRA is a four step risk assessment process that helps stakeholders to understand risks and estimate capability requirements. FEMA requires all states, UASIs, and tribal nations to complete a THIRA on an annual basis in order to receive federal homeland security grant dollars.

The Management Team updated the 2016 THIRA and presented it to the Approval Authority for approval and subsequent submission to Cal OES and then FEMA. The THIRA is based on information obtained during the year, local subject matter expert input, existing Bay Area plans and reports, real world scenarios, resource modeling and estimation resources, and other open source research.

Haystax Project Manager Jason Carroll presented a background briefing on the THIRA process and highlights from this year as well as results from the THIRA Workshop held in September. The results included whole community participation, scenario updates, capability target revisions, and resource requirements review.

(a) Management Team Update

Emergency Services Coordinator

Anthony Perez has joined the Bay Area UASI Management Team as our new Emergency Services Coordinator I. He will be responsible for supporting the day to day operations of the Bay Area UASI office, coordinating all aspects of the Approval Authority's monthly meetings, assisting project managers in the preparation of reports and other technical materials, and providing customer service to the general public.

Anthony completed an internship at PG&E as an Emergency Preparedness Administrative Assistant where he supported company-wide emergency training exercise design and evaluation as well as provided support for various administrative functions. He has also worked for the Federal Reserve Bank, the US Secret Service, and the Federal Aviation Administration. Anthony served our country for 6 years in the US Air Force. He holds a BS in Homeland Security from Embry-Riddle Aeronautical University and is completing his Master's Degree in Public Policy from San Francisco State University.

Bay Area UASI Interns

The Bay Are UASI Management Team will be hosting two interns who are enrolled in the Public Affairs Master's Degree Program at the UC Berkeley Goldman School of Public Policy: Ryan Millendez and Chloe Brown.

Mr. Millendez will work with Catherine Spaulding to survey the field of local cybersecurity response as well as identifying local cyber security risks and strategic opportunities for the Bay Area UASI and its stakeholders. Prior to beginning his graduate studies, Ryan served five years in the US Army working in the fields of Air Defense Artillery and Space and Special Technical Operations.

Ms. Brown has worked as a senior analyst for the US Government Accountability Office (GAO) focusing on homeland security and technology issues. She will work with Corey Reynolds on an interoperability analysis project, which will include an analysis of the region's voice interoperability, developing a strategy or roadmap for UASI engagement in FirstNet planning, and identifying potential future investments in public safety broadband.

Discussion:

Captain Anthony Ceraolo assumed command of U.S. Coast Guard Sector San Francisco on July 19, 2016 and serves as the Sector Commander and the Captain of the Port. As such, he leads over 780 Active and Reserve Coast Guardsmen operating four Cutters, seven Search and Rescue Stations, an Aids to Navigation Team and a Vessel Traffic Service. His area of responsibility spans from the Oregon border to the San Luis Obispo County line and includes over 2,500 miles of shoreline within the San Francisco Bay and its tributaries.

Capt. Ceraolo has served in numerous capacities both shipboard and ashore, including command of the Coast Guard Cutters "Point Camden" and "Neah Bay", service as Coast Guard Liaison and instructor at the U.S. Naval Academy, and numerous command capacities, most recently the Coast Guard Patrol Forces Southwest Asia (PATFORSWA) in 2015. Based in Manama, Bahrain, PATFORSWA is the Coast Guard's largest command outside the United States. As Commodore, he was responsible for six 110' Island Class patrol boats and 240 Coast Guard men and women based in Bahrain and Kuwait.

He holds a Bachelor of Science degree in Government with honors from the U.S. Coast Guard Academy, a Master of Public Administration degree from Harvard's John F. Kennedy School of Government, and a Master of Arts degree in National Security and Strategic Studies with distinction from the U.S. Naval War College. He is a graduate of the U.S. Naval War College's College of Naval Command and Staff in Newport, Rhode Island and the Joint Forces Staff College in Norfolk, Virginia.

Captain Ceraolo has been awarded the Legion of Merit, Defense Meritorious Service Medal, three Meritorious Service Medals, the Coast Guard Commendation Medal, the Navy/Marine Corps Commendation Medal, and 3 Coast Guard Achievement Medals with "O" Device, as well as several unit and service awards.

The FY17 UASI Project Proposal Guidance states that Approval Authority Members will review/approve proposals for "level one" FY17 regional projects at the January 2017 meeting. These projects include training and exercise, fusion center, public safety information sharing, Bay RICS/ interoperability, public health and medical, highly specialized and unique regional equipment, and projects implemented by the Management Team.

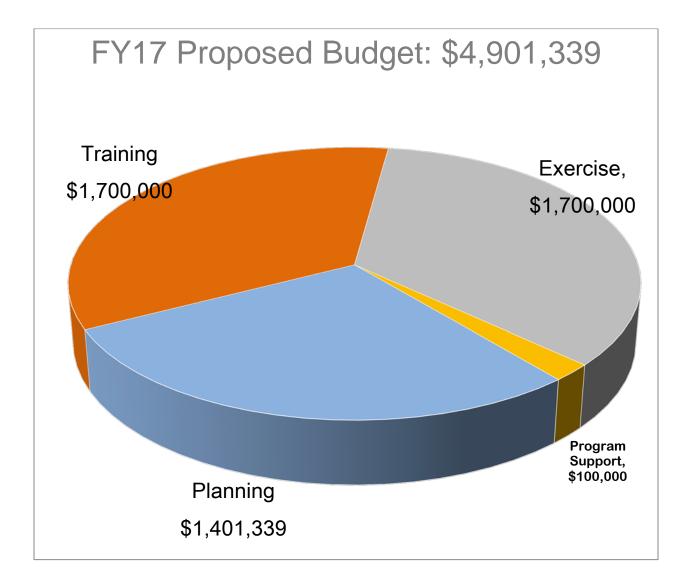

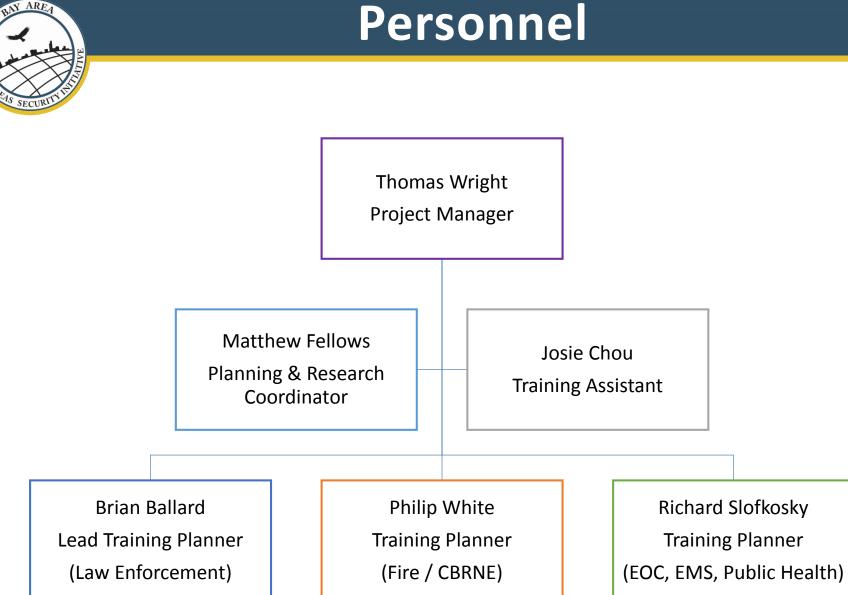

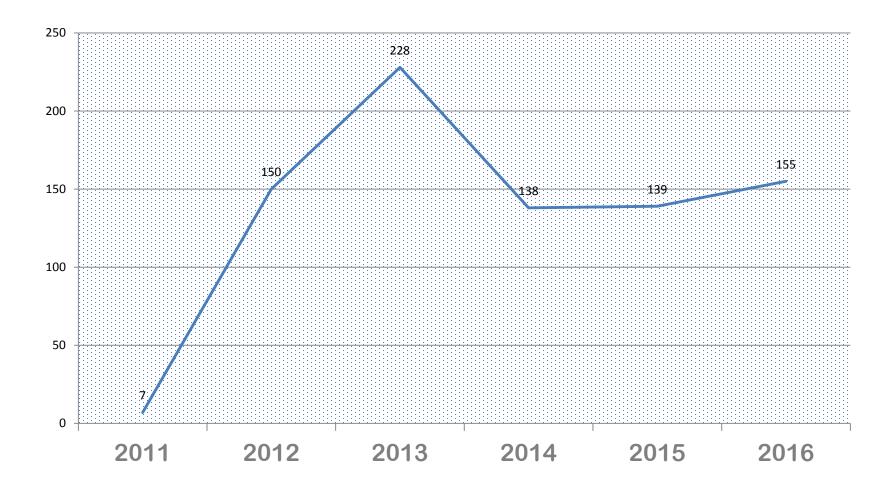

Total Courses Offered (2011 – 2016)

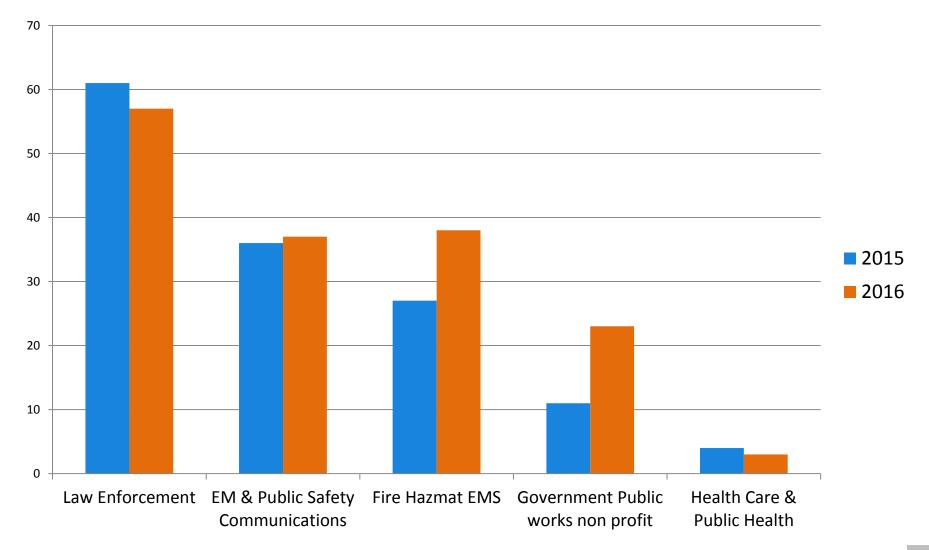

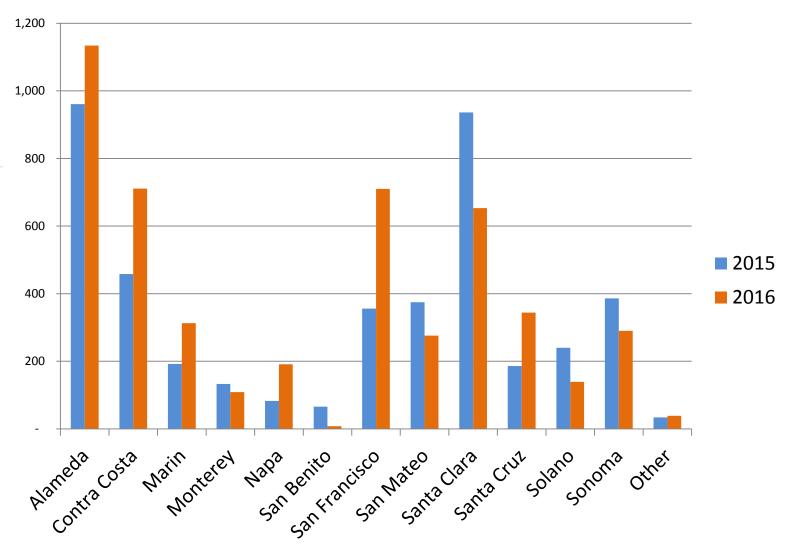

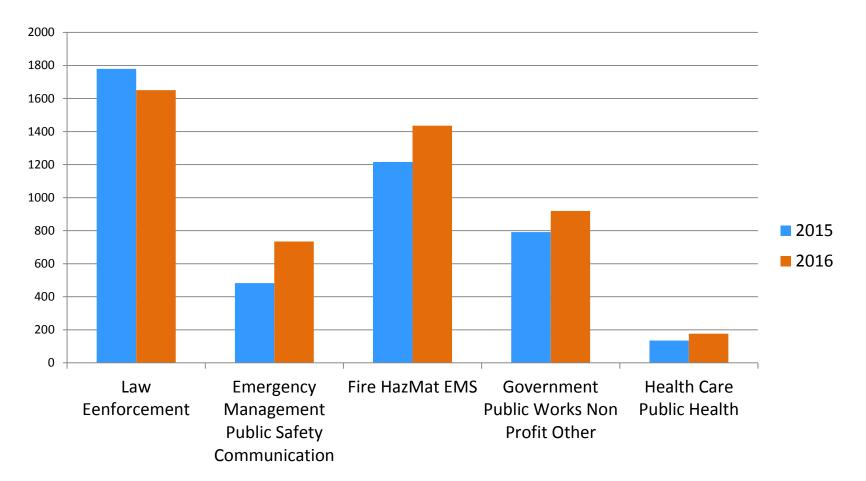

Discussion/Description:

The Northern California Regional Intelligence Center is the State designated and federally recognized fusion center for the region. As a multi-jurisdictionally staffed center with many subunits and disciplines the fusion center is dedicated to the mission of information sharing, training and providing analytical support to both the public safety and private sector critical infrastructure partners within the UASI Area and the Northern Federal District of California.

The Homeland Security Grant Program (HSGP) plays an important role in the implementation of the National Preparedness System (NPS) by supporting the building, sustainment, and delivery of core capabilities essential to achieving the National Preparedness Goal (NPG) of a secure and resilient Nation. Delivering core capabilities requires the combined effort of the whole community, rather than the exclusive effort of any single organization or level of government. The HSGP's allowable costs support efforts to build and sustain core capabilities across the Prevention, Protection, Mitigation, Response, and Recovery mission areas, including the following priorities:

- Building and Sustaining Law Enforcement Terrorism Prevention Capabilities
- Maturation and Enhancement of State and Major Urban Area Fusion Centers

DHS preparedness grants continue to support <u>designated State and major Urban Area fusion</u> <u>centers</u> and the maturation of the Information Sharing Environment (ISE). Fusion centers, a critical component of our Nation's distributed homeland security and counterterrorism architecture, provide grassroots intelligence and analytic capabilities within the state and local environment. The NCRIC as part of the 78 centers that comprise the National Network of Fusion Centers participates in an assessment process that enhances the fusion centers' capacity to improve the nation's ability to safeguard the homeland and prevent terrorist and criminal activity, while enabling local officials to better protect their communities.

Per section 2006 of the *Homeland Security Act of 2002*, (Pub. L. No. 107–296), as amended (6 U.S.C. § 607), the Federal Emergency Management Agency, or FEMA, is required to ensure that at least 25 percent (25%) of the funds appropriated for the Homeland Security Grant Program and related programs are used for law enforcement terrorism prevention activities, as defined in the *Homeland Security Act of 2002*, as amended, and are linked to one or more core capabilities within the National Preparedness Goal.

The Department of Homeland Security also encourages Homeland Security Grant Program recipients (i.e., states, UASI jurisdictions, and territories) to consider allocating law enforcement terrorism prevention activities-focused grant funding on the following activities that are also supported or managed in our region by the NCRIC:

- Implementation and maintenance of the Nationwide Suspicious Activity Reporting (SAR) Initiative, including regional training with the goal of enhanced reporting of suspicious activities and efforts to increase SAR reporting for small, medium, and large law enforcement agencies;
- Regional counterterrorism training programs for small, medium, and large jurisdictions to exchange information and discuss the current threat environment, lessons learned, and best practices to help prevent, protect against, and mitigate acts of terrorism;
- Support for coordination of regional full-scale training exercises (federal, state, and local law enforcement participation) focused on responding to terrorism-related events and increasing participation with community and business organizations;
- Development of countering violent extremism (CVE) programs, projects, and initiatives, addressing prevention, intervention, and diversion efforts, including training on roles of law enforcement and how to effectively partner with law enforcement; developing and promoting training specifically for law enforcement executives and frontline officers on potential behaviors and indicators of violent extremism and how to appropriately analyze and report them; supporting community and law enforcement engagement strategies such as table top exercises, roundtable events, town hall meetings, and peer to peer activities; funding for existing and expansion of law enforcement community relations efforts, support for the development of community engagement plans, and joint projects to increase the awareness of violent extremist threats and community mitigation solutions; and

• Maturation and enhancement of designated state and major urban area fusion centers, including information sharing and analysis, threat recognition, and terrorist interdiction.

Efforts to enhance coordination between criminal intelligence and real time crime analysis units, to include Joint Terrorism Task Forces (JTTFs), Field Intelligence Groups (FIGs), High Intensity Drug Trafficking Areas (HIDTAs), and Regional Information Sharing Systems (RISS).

In addition to the allowable law enforcement terrorism prevention activities referenced in the National Prevention Framework noted above, the law enforcement terrorism prevention activities identified in Section 2006 of the Homeland Security Act of 2002, as amended, remain allowable and are listed below:

- Information sharing and analysis;
- Target hardening;
- Threat recognition;
- Terrorist interdiction;
- Overtime expenses consistent with a State homeland security plan, including for the provision of enhanced law enforcement operations in support of Federal agencies, including for increased border security and border crossing enforcement;
- Establishing, enhancing, and staffing with appropriately qualified personnel State, local, and regional fusion centers that comply with the guidelines established under section 210A(i) of the Homeland Security Act of 2002, as amended;
- Paying salaries and benefits for personnel, including individuals employed by the grant recipient on the date of the relevant grant application, to serve as qualified intelligence analysts;
- Any other activity permitted under the DHS Fiscal Year (FY) 2007 Program Guidance for the preceding Law Enforcement Terrorism Prevention Program; and
- Any other terrorism prevention activity authorized by the Administrator of FEMA.

The Northern California Regional Intelligence Center is the State designated and Federally recognized fusion center for the region. As a multi-jurisdictionally staffed center with many subunits and disciplines the fusion center is dedicated to the mission of information sharing and providing analytical support to both the public safety and private sector critical infrastructure partners within the UASI Area and the Northern Federal District of California. The following information is being provided to give an overview of the fusion centers activity from January to December 6, 2016.

TERRORISM LIASION OFFICER OUTREACH PROGRAM - (TLOOP)

The NCRIC has ten (10) members assigned from various public safety agencies who are dedicated to providing outreach and training to our partners. The TLOOP members are also responsible for reviewing all submitted Suspicious Activity Reports (SAR) and through the Threat Evaluation Unit process follow up on SARs and threats to public safety that require additional information collection and dissemination.

Suspicious Activity Reports (SARs):

373 of 878 SARs required follow-up from the TLOOP as part of the Threat Evaluation Unit process

<u>Total Number in our Distribution List:</u> 12,334 NCRIC Members Approved for Law Enforcement Sensitive Information 2,785 NCRIC Members Approved for Official Use Only Information

INFORMATION TECHNOLOGY—CYBER

The NCRIC has four (4) members assigned to IT & Cyber-related functions.

UPDATE—This past year, the cyber team members have advanced their ability to provide support to local agencies and have seen the increased use of the Homeland Security Information Network (HSIN) Cyber Information Network Awareness Room (CIN Aware) and the Cyber Threat Information Exchange program rolled out throughout the State of California with hardware devices placed in

Fusion Centers, law enforcement agencies and critical infrastructure sites to capture Indicators of Compromise. Also, a NCRIC member has also become a member of the MS-ISAC (Multi-State—Information Sharing Analysis Center) Executive Board.

DIGITAL FORENSIC EVIDENCE LABORATORY

The NCRIC has continued with its support for local law enforcement through the creation and staffing of the NCRIC Digital Forensic Evidence Lab (DFEL), which in 2016, handled 244 cases. The FBI's Regional Computer Forensics Lab (RCFL) has requested to partner with the NCRIC and assign a NCRIC senior IT analyst to the lab to support our combined mission space in the field of digital evidence support.

RISK MANAGEMENT UNIT

The NCRIC has (2) members assigned to the Risk Management Unit, composed of personnel from the San Mateo Sheriff's Office. The RMU's function is to analyze and mitigate threat, risk and vulnerability, as well as providing Special Event, crime, threat, and disaster support and planning. This year's special event support was the busiest of any year since we started the fusion center. All of the teams within the NCRIC provide personnel to support major events, with coordination though our Risk Management Unit. The NCRIC provides support for events in our region based on the potential risk of criminal, including terrorism, attack to the event and requests for assistance from federal and local agencies to provide real-time information sharing and analytical support. This year we supported months of planning activity and 24-hour operational support for the Super Bowl. The NCRIC also provided support to federal and local law enforcement agencies for major sporting events from the NFL, NBA, NHL, PGA, to world soccer events in our area throughout their seasons along with other large scale special events that required large public safety resources to protect.

PRIVATE SECTOR OUTREACH

There are two (2) members assigned to the Private Sector Outreach Program.

UPDATE- During calendar year 2016, the NCRIC Private Sector Program (PSP) added 88 new members, for a total membership of 1,004.

During 2015, the Private Sector Program Director chaired the following subcommittees to further enhance information sharing efforts between fusion center personnel and the private sector:

The Center for Analytic Excellence -Private Sector Engagement Subcommittee which was established by the National Fusion Center Association (NFCA) to enhance the overall ability of the National Network Fusion Centers to support efforts to secure critical infrastructure by working more effectively with the private sector and the 16 Critical Sector Information Sharing & Analysis Centers (ISAC). This committee involves national participation by Federal, State and local government officials, and is being supported by the Program Manager for the Information Sharing Environment (PM-ISE) from the White House.

The NCRIC Private Sector Program director was a guest lecturer on several occasions at the Naval Postgraduate School.

The Private Sector Outreach Team coordinated the Building Communities of Trust meetings held in San Francisco and Mountain View whereby members of the community (CAIR, ADL, ACLU, etc.) were invited to meet with Federal, State and Local law enforcement in a trust-building and information-sharing environment. This year the BCOT meetings supported the development of a webinar for public safety on ISIS and Islamophobia with attendees from the Bay Area and across the United States that was hosted by the NCRIC and presented by our partners representing the interest of our region's Muslim communities

ANALYTICAL SUPPORT (NCRIC- AMT, VAT, Priority Crimes)

There are seventeen (17) members assigned for various analytical disciplines. Those assigned to the Assessment & Monitoring Team (AMT) conduct analysis in both transnational and domestic terrorist organizations. The Vetting & Awareness Team (VAT) conducts analytical support for other law enforcement's request for information, as well as providing analysis of Suspicious Activity Reports. The Priority Crimes Unit provides analysis for regional criminal activity and of those who are released from custody under the provisions of Assembly Bill 109 (AB109).

The NCRIC team prepared and processed:

- 140 Special Event Threat Assessments (SETAs) for our regional public safety partners.
- 87 Situational Awareness products regarding criminal threats.
- 878 SARs for de-confliction and determination of criminal, including terrorism, nexus.
- 773 Requests for Information from law enforcement agencies.
- 512 Requests to produce intelligence background packages for subjects under investigation by federal, state and law enforcement agencies.
- 116 Investigative case support requests.
- 96 LES and FOUO Partner Update Briefs regarding SARs, regional crime trends and national threat reporting.

HIGH INTENSITY DRUG TRAFFICKING AREA (HIDTA)

The Northern California High Intensity Drug Trafficking Area (NCHIDTA) has twenty-two (22) members assigned to support investigation and intelligence analysis for drug trafficking organizations in our region. The NCHIDTA team members represent the Investigative/Intelligence Support Center (ISC), the Investigative Equipment Program, and the Training Program. The HIDTA is a critical component of the fusion center with analysts and investigative resources able to support major homeland security investigations and major special event support. The NC HIDTA ISC supports sixteen (16) counter drug task forces in the twelve (12) county HIDTA area of responsibility, providing analytical case support, de-confliction services, geo-mapping, information requests and case referrals. The ISC is made up of Intelligence Analysts from the CA National Guard, Drug Enforcement Administration, Federal Bureau of Investigation, and the County of San Mateo. The Investigative Equipment Program lends high-tech equipment activities. The Training Program provided law enforcement officers, analysts, and management level personnel with training in 107 classes related to investigations, intelligence, and officer safety.

PILOT PROJECTS

The NCRIC was involved in several national Pilot Projects in 2015 with some that have developed into national policy and guidance and others that are continuing into 2016:

- The FBI's Enhanced Engagement Strategy, which is a joint FBI, DHS, ISE, Fusion Center collaborative project focusing on enhancing the analytical cycle and coordination of counter-terrorism threat identification, prevention, mitigation and investigation. This Pilot that concluded in June of 2015 and was chaired by a NCRIC member has resulted in the FBI's adoption of the Enhanced Engagement Strategy to develop a path for fusion centers and the FBI to expand collaboration and capabilities.
- The Fusion Center-Cyber Pilot, was a joint FBI. DHS, ISE, CIS, Fusion Center collaborative project focusing on the analysis and dissemination of cyber threats. The NCRIC co-chaired pilot concluded on April 2015 and developed a cyber integration for fusion centers document that is now national guidance.
 (https://www.cisecurity.org/documents/Cyber Integration for Fusion Centers.pdf) The NCRIC continues to lead the national coordination to implement the guidance throughout the National Network of Fusion Centers.
- Analysis of Social Media—is a Fusion Center collaborative project focusing on the identification of best practices in regard to the analysis of information posted on open social media. This is an on-going pilot and is chaired by a NCRIC member. It involves collaboration with the FBI, DHS, ISE, other Fusion Centers around the US, Johns Hopkins University and other federal agencies. The working group is completing a product for national distribution regarding best practices and resources.

Training for Calendar Year 2016 up to December 6th:

156 training classes related to homeland security, narcotics enforcement, law enforcement officer safety and investigative techniques were provided or coordinated by the NCRIC and the HIDTA in partnership with our allied agencies and organizations.

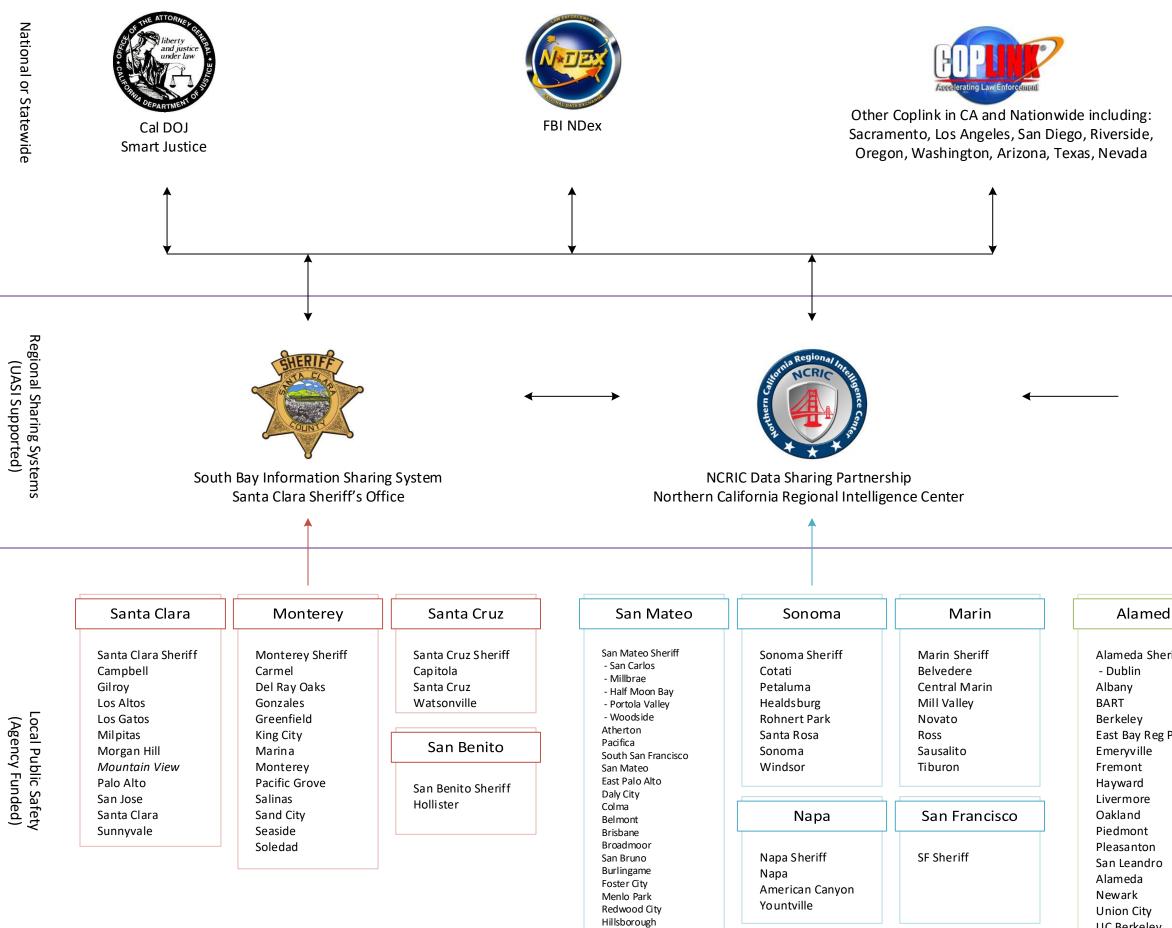

The Management Team, on behalf of the regional working groups, proposes two projects for FY17 UASI regional funding:

Preventive Radiological Nuclear Detection

With the oversight of the Bay Area UASI Preventive Radiological Nuclear Detection (PRND) focus group, the Management Team proposes to use \$315,000 to purchase detection and interdiction PRND equipment as identified in the October 2016 Bay Area UASI PRND Gap Analysis. The funding will also support training sessions, exercise design, and a full scale exercise for Bay Area first responders to test and validate the 2016 Bay Area PRND Concept of Operations Plan.

Mass Care and Sheltering

With the oversight of the Bay Area UASI Emergency Management Workgroup, the Management Team proposes to use \$150,000 to conduct workshops, a needs assessment, and a sheltering strategy for Bay Area local jurisdictions. The project will establish sheltering roles and responsibilities in a disaster, document locations and access to facilities and supplies, and support local jurisdictions to refresh/complete MOUs with the American Red Cross (ARC) and other non-government agencies. The Emergency Management Workgroup formed the Care and Shelter Sub-Committee in April 2016 per the Approval Authority's request to clarify ARC sheltering agreements. The sub-committee's two year project charter is provided in Appendix B.

- 5. Establish action plans to refresh and complete MOUs with ARC and other non-government agency partnerships.
- 6. Coordinate with FEMA IX/CalOES Bay Area Earthquake Plan (BAEP) exercise calendar to align shelter operations exercise objectives and work with UASI jurisdictions to customize local exercise objectives to design a two year exercise schedule to build up to a Full Scale Exercise activating shelters in 2018 Yellow Command/Urban Shield.

Calendar Year 2018 (FY17 performance period Jan-Dec 2018)

Activities for 2018 will be based on the strategy developed in item 1 above and improvement items identified during 2017 workshops and exercises. The following are anticipated and may be revised through discussion with the Care and Sheltering Subcommittee.

- 10. Develop materials for Mass Care and Shelter Leads within EOCs including EOC position checklists, job aids, and quick guides.
- 11. Develop updated shelter survey templates to account for west coast climate / conditions.
- 12. Continue supporting updates to local MOUs with ARC and other non-government agency partnerships.
- 13. Coordinate with the Yellow Command Exercise Planning Team to incorporate full-scale activation of shelters into the exercise in 2018.

III. Purpose

• Problem/Opportunity:

UASI jurisdictions do not have updated non-government agency agreements, identified facility, staff and/or resources required to satisfy local government regulated care (feeding) and sheltering obligations in order to meet the anticipated needs of moderate to catastrophic level disasters in the Bay Area. American Red Cross has reorganized, making it an ideal time for local governments to re-establish partnership agreements and understand the resources they can expect from ARC. Equipment, shelter facility identification, facility agreements, and updated roles and responsibilities must be defined to effectively respond in a sheltering incident.

• Solution/Vision:

Build capabilities over a two year period for local government to perform care and sheltering functions, including serving access and functional needs populations, coordinated pet sheltering and medical conditions operations, throughout the Bay Area. Leverage previously developed sheltering tools, training and planning in other UASI areas including City of LA and San Diego County and utilize lessons learned from California real world incidents such as the 2015 Rocky and Valley Fires. Using the UASI RFQ vendor list, leverage UASI management team staff for project management services and to coordinate with the FEMA IX/CalOES Bay Area Earthquake Plan (BAEP) exercise efforts.

• Outcomes:

The Bay Area jurisdictions and agencies will have a defined strategy and be trained on roles and responsibilities for serving anticipated mass care and sheltering needs throughout the region. UASI jurisdictions will have access to a virtual database / map of facilities with pre-existing shelter agreements and supply caches noting appropriate attributes (e.g. POC, facility maps, staffing and resource needs for all displaced population types, medical conditions sheltering capabilities, companion pet and large animal co-sheltering operations, mobile vet clinics).

BayRICS General Manager Barry Fraser will provide a BayRICS Joint Powers Authority Quarterly Report and three requests for regional funding as described below. Please see Appendix A for a PowerPoint presentation.

Request # 1: Regional Broadband Planning and Governance Year 3 (05942) Amount Requested: \$59,000

This funding will provide partial support for year three of the BayRICS regional broadband planning and governance project. The grant will pay for contract services to help the Bay Area plan for the deployment of the FirstNet nationwide public safety broadband network, and to develop and implement regional governance policies and procedures. Deliverables will include a report detailing the pros and cons of adopting FirstNet services and recommendations for Bay Area agencies. It is anticipated that this will be the final year of planning for FirstNet, as the network

is expected to be deployed during 2018. The FirstNet network will enable first responders to share critical information to prevent, respond to and recover from terrorist attacks.

The project will support regional planning and governance for public safety broadband communications in Alameda, Contra Costa, Marin, San Francisco, San Mateo, Santa Clara and Sonoma County operational areas.

Request # 2: Wireless User Equipment for FirstNet Nationwide Public Safety Broadband Network (05944)

Amount Requested: \$200,000

It is anticipated that the FirstNet network will be deployed during 2018. The grant will support terrorism preparedness by funding end user equipment for Bay Area agencies to operate on the FirstNet nationwide public safety broadband network. Funding will pay for approximately 200 handheld "smart phone" type devices to be distributed equitably among Bay Area operational areas that adopt FirstNet services. Devices will be capable of operating on the FirstNet spectrum band class 14, or easily upgraded to the FirstNet band when the service is available. User training is expected to be provided by FirstNet. The equipment funded by the grant will enable first responders and emergency managers to share critical information to prevent, respond to and recover from terrorist attacks.

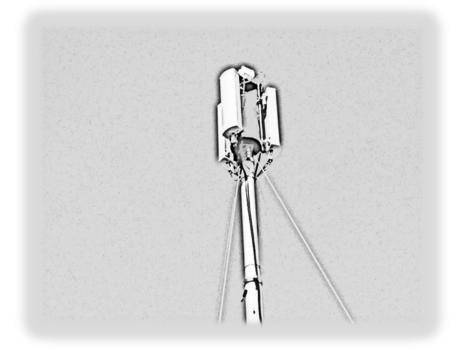
The project will support regional adoption of interoperable wireless broadband communications by public safety in all Bay Area operational areas.

Request # 3: Exercise Scenario Development for P25 Radio Systems (05998) Amount Requested: \$50,000

The Bay Area devised a system-of-systems approach to upgrading the region's public safety radio systems to Project 25 standards-based technology, with the understanding that the technology would be interoperable for mutual aid purposes. BayRICS Authority is tasked with coordinating technical activities to ensure that these separate systems are fully interoperable. Initial tests have identified additional training and exercise needs for Bay Area first responders. This funding would support development of enhanced exercise scenarios to simulate live operational conditions experienced by law, fire and EMS personnel. This funding will also support testing of interoperable radio systems that would be used to prevent, protect against, respond to and recover from terrorist attacks.

This project will support interoperability among P25 radio systems operating in Bay Area operational areas.

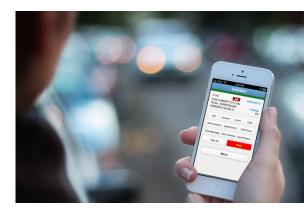

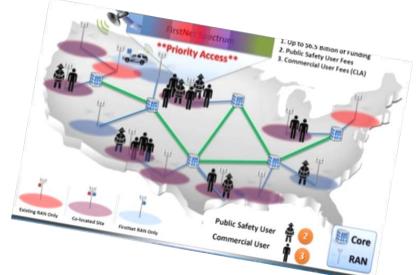

The FY17 UASI Project Proposal Guidance states that Approval Authority Members will review/approve proposals for "level one" FY17 regional projects at the January 2017 meeting. For the first time this year, this includes "highly specialized and unique regional equipment." The Guidance also states that such equipment must address a gap stated in a local or state after action report and must have an endorsement from a Bay Area UASI work group that it meets the "highly specialized and unique" threshold.

There is one such regional proposal submitted this year for funding from the FY17 grant: Aerial Intelligence and Communication System (Sonoma). Please see the table on the next page and item appendices for more information.

Based on information submitted for review, the Management Team does not believe this project meets the threshold of "highly specialized and unique" equipment. However, the project was endorsed by the CBRNE Work Group and provided relevant after action report information.

The Management Team recommends funding the project at \$100,000 from leftover UASI funds from prior grant years. We make this recommendation due to the fact that several Approval Authority Members expressed support of using leftover grant funds for this project at the April 2016 meeting, and stakeholders expressed support for this project during its vetting at the November 17 CBRNE Work Group meeting.
